Students Ask Legislators to Stop Bullying and Discrimination

Student Advocates to Call on Elected Officials to Protect Against Bullying and Discrimination

WHAT: On Monday, April 4, nearly 70 California students who are lesbian, gay, bisexual, transgender (LGBT) and straight allies will participate in the annual Queer Youth Advocacy Day. By meeting with state legislators and administrators in Sacramento, students will raise awareness about issues affecting LGBT middle and high school students, including the need for stronger protections against anti-LGBT bullying and discrimination and the lack of social science instruction on the contributions of LGBT people. The event is sponsored by Gay-Straight Alliance Network, Equality California, Transgender Law Center, and The Trevor Project.

Youth leaders will arrive in Sacramento on Friday, April 1 to participate in a three-day educational training called the GSA Advocacy & Youth Leadership Academy (GAYLA). The educational training will cover the legislative process, policy advocacy, media activism, and other important leadership skills for students working to change cultural perceptions and treatment of LGBT students in school. Youth leaders will then participate in Queer Youth Advocacy Day on Monday, April 4.
